In 2019, the American Hospital of Paris held its first international Harvey Cushing Symposium focusing on artificial intelligence and medical imaging, in partnership with *Université Paris Descartes*, NewYork-Presbyterian Hospital, Columbia University, Weill Cornell Medical College and the French-American Foundation. Internationally recognized specialists offered answers to many questions surrounding the growing use of AI in imaging, such as: How can images be interpreted more accurately and reliably?

The American Hospital of Paris Introduces Artificial Intelligence

Artificial Intelligence (AI) is everywhere and is gradually transforming all sectors of human activity. Medicine and hospitals are no exception to the rule. When it comes to health care, AI offers tremendous opportunities for both doctors and patients.

Today, the American Hospital of Paris has become one of Europe's leading institutions in this field, not only by offering patients initial applications in imaging, but also by developing highly promising research projects. As always, our goal remains unchanged: deliver the best in French and American medicine to our patients.

Beware of preconceived ideas! Far from the scenarios conjured by sci-fi movies and novels, AI is not a superintelligence on the verge of replacing humans - especially when it comes to medicine! Each AI solution is based on a unique mathematical algorithm which is fed large amounts of patient data and programmed to respond to a specific question in a given medical field. Artificial intelligence is undeniably a powerful technology, but it was essentially designed to accomplish a single task which is often time-consuming and tedious for doctors. There's a reason such technology is being introduced into hospitals via medical imaging. As imaging devices become more and more sophisticated, they generate increasingly large numbers of images



- 1,000 to 1,500 per exam. The radiologist must analyze these massive amounts of data before making a diagnosis. It's easy to imagine the complexity of such a job and the irreducible amount of time it requires. By helping doctors process this data by identifying any "suspicious" images (those showing an abnormality) in record time, AI reinforces the accuracy of medical expertise, saving doctors valuable time that can be used instead to focus on any red flags. Today, the American Hospital of Paris wants to **make artificial intelligence a clinical reality** to improve its patients' health. In France and across Europe, our hospital is considered to be a pioneer because we are incorporating AI into routine care for certain diseases and the associated medical exams.

Under the leadership of Professor Jean-Luc Sarrazin, Chief of Medical Imaging, Nuclear Medicine and Interventional Radiology, the American Hospital of Paris is partnering closely with INCEPTO, a provider and creator of AI solutions dedicated to medical imaging. Through this partnership, three innovative solutions are being installed in strategic areas for the American Hospital of Paris. In their respective fields, these innovations will guarantee the reliability and high level of medical expertise we deliver to our patients, through more accurate and ultra personalized diagnostics and extremely precise quantitative monitoring.



Breast cancer diagnosis: The new interactive solution was "trained" by analyzing more than one million images. It identifies the most suspicious areas on 2D and 3D mammograms. Results are given a score based on the risk of the presence of cancer, allowing the doctor to confidently give priority to certain exams.



Early detection of lung cancer: This solution automatically detects and measures lung nodules as well as their growth rate and composition, the aim being the very early detection of lung cancer. This is good news knowing that at Stage 1, the five-year patient survival rate is 80 percent, and that without a national screening campaign, at-risk populations are usually diagnosed too late.



Neurodegenerative diseases: By acquiring an application to automatically monitor and measure brain lesions caused by multiple sclerosis, Alzheimer's and other similar diseases, our doctors will be able to predict how these lesions will evolve over time and, more importantly, determine the most appropriate treatment for each patient within a much shorter timeframe. Faced with the challenges inherent to these pathologies, our patients will benefit from the best possible care available.

of new solutions by participating in a research project launched by Columbia University. This major project aims to improve the detection of microcalcifications in breast cancer screening. As Dr. Marc Abehsera, a radiologist specializing in breast disease, explains, "During *a mammogram, microcalcifications* might be detected. They are usually benign, but sometimes appear in particular patterns that could signal an early stage of cancer. In this case, the patient may undergo an imageguided stereotactic core needle biopsy under local anesthesia, and possibly surgery. By using AI software that can characterize microcalcifications when reading the images, we will spare many patients an unnecessary biopsy or surgical procedure. Columbia University has developed a solution that does just that. It is currently in the deep learning phase, meaning data from proven cases are fed into the software so it learns to distinguish between benign and malignant cases. The data comes from biopsies and mammograms performed at the American Hospital of Paris, representing no fewer than 10,500 exams in all. It's a herculean task. Our partner, INCEPTO, is assisting us with the collection, analysis, anonymization and transfer of data to Columbia. This AI solution will be operational in a few months. When suspicious microcalcifications are detected, our expertise, combined with the software's analysis, will help us to very rapidly *decide whether to perform a biopsy* or simply recommend monitoring. This truly saves time for doctors while guaranteeing a less invasive approach for patients. We hope this exciting project will be the first of many. We have reached a turning point in the history of medicine and, thanks to our close ties with a university like Columbia, the American Hospital of Paris is fortunate to be playing a key role in events."

FOCUS ON THE WOMEN'S RISK INSTITUTE

When Artificial Intelligence Predicts Breast **Cancer Five Years Ahead Of Clinical Signs**

In 2018, the American Hospital of Paris created the Women's Risk Institute, an innovative breast cancer risk detection program initiated by Professor Mahasti Saghatchian. Here, artificial intelligence and genetics are used to predict the possible occurrence of cancer up to five years before any visible anomalies appear. This offering from the American Hospital of Paris - a highly innovative and complete assessment that takes only an hour and a half to perform – is unique in its field in Europe.

1. Each patient's data is fed into an AI algorithm which employs a unique statistical method based on the clinical data of one million American women and 350,000 French women who were monitored for 20 years. The algorithm determines a risk percentage by identifying the patient's "virtual equivalent" in its database.

2. The AI software also conducts a comparative analysis of the patient's breast density revealed by the mammogram. Pixel by pixel, it ascertains the relationship between the fibrous tissues and fat tissues, comparing the results to data in its base. This task, impossible for the human eye, is nevertheless crucial as breast density is directly correlated to the risk of cancer.

Through this program, the American Hospital of Paris is able to closely monitor at-risk patients and diagnose a potential cancer at the earliest occurrence of precancerous cells. This reduces the use of invasive treatments to a minimum while guaranteeing a faster recovery

3. Through a partnership with Institut Curie, the patient's genetic profile is determined based on a saliva sample. The combination of 76 genes is compared to the genetic data of thousands of Caucasian women, making it possible to establish each woman's individual predisposition to breast cancer.



4. All of this data is compiled by Mammorisk, a software solution that evaluates a woman's risk of developing breast cancer over the next five years and determines the appropriate imaging protocol for prevention and monitoring.



EMERGENCY Covid-19

In February, the American Hospital of Paris completely reorganized its services, and all medical and nursing teams are fully mobilized to weather the unprecedented Covid-19 health crisis.

A specific circuit for suspected Covid-19 patients is in place in the Medical-Surgical Unit to avoid any risk of contamination. In accordance with health authority directives, all nonurgent activities, including consultations, health check-ups and imaging exams, have been cancelled. Access and visits to the hospital are restricted to protect patients and free up hospital beds. In March, in coordination with the Ile-de-France Regional Health Agency, the American Hospital of Paris was authorized to admit Covid-19 patients and thereby contribute to managing this major crisis. Care is administered to these patients in designated areas by designated staff in compliance with the highest safety standards. Our critical and continuous care units are also fully prepared to treat the most fragile patients. During this unprecedented health crisis, the American Hospital of Paris is and will continue doing everything in its power to take care of you and your loved ones, should you require hospitalization.



QUALITY OF CARE Level A Certification by the *Haute* Autorité de Santé

The American Hospital of Paris is the only hospital in the world to be simultaneously accredited by the American Joint Commission, based on the same criteria as hospitals in the United States, and certified by the French Haute Autorité de Santé (HAS), like all hospitals in France. After its last visit in September, the HAS certification commission for healthcare institutions gave the American Hospital of Paris an "A" ranking for a duration of six years – a further guarantee of the quality and safety of the care delivered by the doctors and healthcare teams at the American Hospital of Paris!

New Imaging Center

After initial studies in October 2017 and the groundbreaking in February 2018, our new medical imaging center welcomed its first patient on January 3, 2020. Located under the hospital gardens, the brand new building is bathed in natural light thanks to a central patio featuring large picture windows and an atrium. The two CT scanners and the two MRI machines have been installed and are operational. The second phase of work has begun to restyle the gardens and upgrade the adjoining area, where a latest-generation PET scanner is due to be installed in a few months.

Your Hospital is Renovating to Better Serve You

Following the inauguration of our new medical imaging center in early January in a light-bathed building located under the hospital gardens, and the ongoing renovation of rooms in Building B this year, the American Hospital of Paris has launched a new project to redesign the main lobby of the Florence Gould Pavilion on Boulevard du Château.

To serve its patients under optimal conditions, the American Hospital of Paris will continue to renovate many spaces over the coming years. To facilitate these projects, before the end of spring the hospital's main entrance will be relocated to the Florence Gould Pavilion's main lobby, also known as Building F, located at 55 Boulevard du Château.

A comfortable and inviting new lobby is currently being installed featuring three reception desks, the admissions office and waiting areas. *Parenthèse* restaurant is also being remodeled, and a newsstand will be added near the garden's entrance.

Parenthèse will be closed for seven weeks. It will reopen in June in a modern and welcoming new space which will include a tea room and lounge area open all day.

The tea room located on the second floor near the main lobby will be open during the renovation for lunchtime snacks.

Please note: Due to the Covid-19 epidemic in France, the dates mentioned in the above article could be postponed by several weeks. Outside the building, the sidewalks and roads will be adapted to allow vehicles to drive right to the entrance of the Florence Gould Pavilion. In addition, free valet parking will be available, enabling all patients and visitors to leave their car with a professional who will park it in the building's underground lot and return it to them when they are ready to leave the hospital.

Access to the Medical-Surgical Unit and Pediatric department will remain unchanged at 63 Boulevard Victor Hugo.

In June, the Hospital's entrance will be temporarily relocated to 55 Boulevard du Château in the Florence Gould Pavilion, to facilitate additional renovation projects in your Hospital.

What if You Got to Decide Where Your Tax Money Goes by Investing in a Major Medical Innovation?

The American Hospital of Paris, a private, not-for-profit organization, receives no public subsidies from the French or American governments. Your generosity is the only resource that guarantees we will have the necessary funding to ensure the growth and longevity of our hospital. Nevertheless, to encourage all support in favor of the AHP, our status as an institution of public benefit, granted in 1918, allows benefactors like you to deduct a percentage of your donation from your tax bill. This tax incentive is especially substantial when applied to the French wealth tax on real estate assets (IFI).

If you are a French taxpayer or foreign resident in France who is required to pay the IFI tax and whose real estate holdings are subject to taxation, French law allows you to reduce this tax by freely allocating it to an organization like ours. For you, this is a double opportunity, because you get to decide how your IFI tax money is spent, by putting it to work for your health and that of your loved ones. Soon it will be time to file your income and asset tax returns (between May 14 and June 2 depending on your filing method and the French *département* where you live). I encourage you to take advantage of this tax incentive so you can deduct 75 percent of your gift to the American Hospital of Paris from your 2020 IFI tax bill.

I am very involved with the Foreign Legion, helping not only the children of legionnaires, but also former legionnaires who are isolated or struggling. I also support the young girls enrolled at Legion of Honor public schools. And then of course, there's the American Hospital of Paris. Maria and I both forged strong ties with this institution. Gradually, we became ambassadors of the hospital, notably thanks to the doctors and their attentive interest in us. As her disease continued to advance, Maria asked me to participate in the renovation of

the oncology department so patients would benefit from greater comfort and well-being. Our agreement was never written down, and that's why it is so important to me. Through my actions, I am honoring Maria's memory. And because it was her wish, these actions translate financially into donations to the American Hospital.

Of course I am interested in medical progress, even though the technical aspects at hand are a little over my head. But what matters most in the support I give is the human factor. At the American Hospital of Paris, there's a sense of altruism and humanity that you don't find anywhere else. David T. McGovern, who was Governor, Chairman then Honorary Governor of the American Hospital of Paris and one of its most generous benefactors for 48 years, passed away on February 7, 2020.

An American who moved to Paris in 1967, Mr. McGovern was an attorney and member of the New York and Paris bars. He demonstrated unfailing commitment to our hospital, where he served as Chairman of the Board of Governors twice (1976-1978 and 1996-2003). He always skillfully guided our organization, at times through delicate situations. He took on the role of volunteer CEO in 2001, centralizing the donations and messages of support from thousands of French citizens to the families of the victims of the September 11 attacks.

Our hospital's dual status allows our donors to benefit from particularly attractive tax deductions in certain countries. Below you will find details about the tax deductions you may be eligible for based on your country of tax residence. These deductions are not available for every country on the planet, but the list of eligible countries is growing in order to encourage donor generosity.



For Donors in France, the United States and Luxembourg

- The American Hospital of Paris is one of the few organizations to issue tax receipts that are directly recognized by the tax administrations of three countries.
- First of all, because our hospital was recognized as an institution of public benefit on March 19, 1918, France authorizes the American Hospital of Paris to issue tax receipts. If you are a French taxpayer, for every donation you make to the hospital, we provide a tax receipt that can be used to reduce either your income tax or your wealth tax on real estate assets.
- As a result of the act of incorporation by the United States Congress in 1913, the hospital can also issue tax receipts that are directly recognized by the Internal Revenue Service (IRS). If you are a US taxpayer, you may benefit from a tax deduction when you make a gift to the American Hospital of Paris.

• Lastly, if you pay taxes in Luxembourg and make a donation to the American Hospital of Paris, a tax agreement between France and Luxembourg lets you benefit from a tax reduction of the same amount as if you had made a donation to a foundation in Luxembourg. Simply include your French tax receipt directly with your tax returns, along with a certificate provided by the hospital.

For European Donors

For most other European countries, a network called Transnational Giving in Europe (TGE) fosters charitable giving.

Each member country* has a reference organization. If you pay taxes in one of these countries and would like to make a donation to our hospital, you must make your donation to the TGE's reference organization in that country, indicating that the gift's end-recipient is the American Hospital of Paris. You will then receive a tax receipt from the country in question, with the assurance that your donation will be transferred to the American Hospital of Paris.

For other countries around the world, check whether a tax reciprocity agreement exists between a given country and France or the United States. Please feel free to contact the Development Office at the American Hospital of Paris for further details or advice.

Most European countries are members of the TGE network, including Belgium, Switzerland and the United Kingdom.

Any tax deduction will be equivalent to the deduction granted by the country in question for a donation made to a local foundation or not-for-profit that is recognized for taxation purposes. This deduction may vary within certain federal states such as Switzerland or the United States.

At the end of April 2020, a new online platform will be made available, with the participation of the TGE network, to further facilitate transnational giving.
