




# **Enhancing the American Hospital of Paris** with a Pediatric Center of Excellence Recognized in France

Children and teenagers have specific health-related needs that require highly specialized care. With support from a major patron, the American Hospital of Paris is seeking to mobilize its outstanding pediatric expertise through an ambitious project of public interest: the creation of a pediatric center, recognized in France, guaranteeing rapid access to medical excellence for children.

### Addressing the Pediatric Medicine Crisis in France

In France, pediatric medicine is unquestionably the sector where the shortage of physicians and nurses is most sorely felt. With only 8,500 practicing pediatricians, France ranks 22<sup>nd</sup> in terms of pediatrician density out of 31 OECD member countries. Waiting lists for pediatric care are getting longer, and these lengthy delays are increasingly becoming a deterrent for families. 80% of children receive their routine medical care from a general practitioner. The situation is likely to worsen, as 44% of pediatricians are over 60 and the specialty is no longer considered attractive.

The Paris region is no exception to the rule. In the capital and its suburbs, access to pediatric care is increasingly complex and limited. Public hospitals alone account for 90% of all pediatric activity in the country. Completely overwhelmed today, these hospitals can no longer meet demand for care, whether planned or emergency. One third of medical emergencies in the Paris region – 3.7 million ER visits per year – involve children under 15. Wait times in pediatric emergency rooms can be up to five hours, while those for simple abdominal surgery can be up to one year. And scheduling an appointment can feel like an obstacle course, with wait times of three weeks for a routine pediatric consultation, and up to six months for a specialist consultation. We must urgently invest in children's healthcare and offer families an effective alternative access to care.

Our project focuses on the delivery of comprehensive and ultra-personalized medical services, including pediatric emergency care, consultations, inpatient and outpatient medicine and surgery by top experts in the field. All of the necessary specialized skills will be available in our surgery unit, particularly in abdominal and orthopedic surgery. In close collaboration with an expanded team of generalist and specialist pediatricians, and using our unrivaled diagnostic and testing equipment which enables specimen removal as well as ultrasound, MRI and scintigraphy exams, we'll be able to handle any situation. And we'll do so with a level of responsiveness that reduces wait times to a minimum."

### **Embodying the Pediatric Medicine** of Tomorrow

Among private hospitals, the American Hospital of Paris is the most well suited to build a general and multidisciplinary pediatric center within its existing infrastructure. The current pediatric unit of the American Hospital of Paris, located in our Department of Women's and Children's Health, is staffed by generalist pediatricians, maternity pediatricians, pediatric nurses and approximately twenty specialist pediatricians. Our Hospital stands out for its exemplary response times, and our state-of-the-art diagnostic and testing infrastructure, combined with unparalleled expertise, enables us to offer exclusive pediatric medical services such as brain MRIs with sedation for autism testing and renal scintigraphy procedures.

However, to effectively meet the healthcare needs of our region's children and teenagers, the American Hospital of Paris must significantly increase its pediatric capacity over the next two years. This will require expanding services in medicine and surgery as well as rethinking the entire pediatric care pathway to ensure continuity and quality at every step of a child's life. Because our pediatric services are currently spread throughout the Hospital's various adult care departments, we will need to create clearly distinguishable units and adapt the environment to the specific needs of children and their families. This will include adding amenities such as sound-proof family waiting rooms, areas specially designed for infants less than three months old, a lactation space, safe equipment, and play rooms.



### Facilitating Rapid Access to Care by Developing a Hospital within the Hospital

Located in the Florence Gould Building (Building F), our center will comprise different spaces entirely dedicated to young patients. In continuous collaboration with the Hospital's cutting-edge medical imaging center, five departments will cover the entire scope of conventional and specialized pediatric medicine while ensuring more fluid care pathways. Shorter decisional and interventional processes will guarantee the rapid delivery of care while boosting efficiency and optimizing outcomes.

### **CONSULTATIONS**

### > 6 consultation rooms

*Easy access to routine care and twenty pediatric* specialties, including cardiology, allergy management, pulmonology, gastroenterology, orthopedics, osteopathy, nutrition, psychiatry, dermatology and neurology.

### **DAY HOSPITAL**

### > 7 chairs and beds

Care delivered through innovative and theme-based pathways that are specific to each child's needs, including abdominal pain, eating disorders, allergy assessments, and rapid diagnosis of respiratory diseases with multiplex PCR testing.

### **MEDICAL SURGICAL UNIT**

### > 3 patient rooms - 1 resuscitation room - 1 inhalation room - 2 play/waiting rooms

*Urgent care for patients with a non-life-threatening* condition (e.g. traumatology, infection) 7 days a week from 8:00 am to 10:00 pm, with management of patient flows via a digital platform to reduce wait times to a minimum.

### **INPATIENT UNIT**

### > 15 beds

Short- and medium-term stays for children of all ages following surgery or emergency care.

#### **SURGERY UNIT**

### > 1 operating room - 1 recovery room

Currently, the Hospital's pediatric surgeons and anesthesiologists can only perform outpatient procedures. To meet high regional demand, the new surgical unit aims to double the number of operations, whether planned or emergency, by expanding surgical services, particularly for abdominal and orthopedic surgery.

# Building a Center of Excellence Recognized in France

In keeping with the American Hospital of Paris's strategy, our pediatric center will be integral to the emergence of our new private hospital model. Based on a hybrid of academic-focused medicine and private medical practice, this model also aims to increase our doctors' participation in activities relating to clinical research, teaching and innovation.



In November, Professor Alain Gervaix will take the helm of the pediatric center. His mission will be to develop synergies with our partners in Paris and in the United States, in particular Necker-Enfants Malades children's hospital, Institut Imagine, Université

Paris-Saclay, Columbia University, Weill Cornell Medicine and NewYork-Presbyterian Hospital. Since 2017, Professor Gervaix has been Head of the Department of Women's, Children's and Adolescent Health at Hôpitaux universitaires de Genève, Geneva's main teaching hospital, where he oversees approximately 1,800 colleagues.

Our ambition is to develop a holistic and ultra-personalized approach, which is crucial to optimizing a child's treatment and care, simplifying the journey for family members, and offering parents greater peace of mind.



Cutting-edge technology applied to 3D ultrasound, AI-assisted cytology, cryoablation and molecular biology enables patients to benefit from quick diagnoses and personalized treatments with minimally invasive, function-preserving procedures. This therapeutic approach aligns with the latest international recommendations and is a result of our collaboration with prestigious institutions such as Weill Cornell Medicine.



# Architectural Transformation: Building K Opening Soon

The unprecedented success of our capital campaign, *Le Nouvel Américain* 2018-2023, has enabled the American Hospital of Paris to expand, modernize and undergo transformation.

Since structural work on Building K was completed last November, dozens of workers have been laboring daily to install the interior finishes and mechanical, electrical and plumbing systems ahead of the building handover, scheduled for next fall.

Beginning in September, Building K will open in several phases to enable each department to efficiently launch its activity, aided by our support teams.

The main entrance will resume its location on Boulevard de la Saussaye, where a drop-off zone, valet service and underground parking lot with 200 spaces will be available.

Dedicated to the medicine of tomorrow, the 100,000-square-foot (10,000-square-meter) building will house new predictive, preventive and rehabilitation medicine units as well as operating rooms, lounge areas and patient services.

The completion of our new flagship building does not signal the end of the Hospital's architectural transformation. Work will continue in 2026 to ensure seamless connections between the new and older buildings, as well as to utilize the freed-up spaces for new Hospital activities.

The first time Agnès Touchet-Chazal stepped inside the American Hospital was in 1984. "My father's best friend was CEO at the time. He opened the doors of this incredible institution to me, where I filled in for people in the summer as a student, then did internships for my bachelor's and master's degrees." Those experiences marked the beginning of a very long relationship with our Hospital – the kind that is seldom found these days. "When I finished graduate school, I applied to the American Hospital. I got my first job there as a secretary in the fundraising department, now known as the Development Office. Back then, there were only two of us in the department!"

In France, fundraising was a fledgling activity in 1989, and still remains a relatively discreet sector today. But in this field, like in so many others, the American Hospital of Paris is a trailblazer. As Agnès discovered her profession and the world of philanthropy in general, she developed a passion for her work, in part because of its emphasis on human relations. "Over time, I built strong ties with certain donors, some of whom even became dear lifelong friends, like Christiane Guerlain. Working in philanthropy means you are constantly interacting with people, and I never wanted to do anything different." Nor could she imagine working anywhere else, despite multiple offers. "I truly admire our Hospital and the way it operates, as well as all the people who represent it and carry out its missions every day. When I first joined the American Hospital, I was struck by the teams' humanistic approach and friendliness, by the family-like atmosphere and spirit of community. I felt an immediate attachment."

Perhaps it was this sincere and deep attachment that, around ten years ago, inspired Agnès to consider her relationship with "I believe in the institution – in its commitments and ability to make progress and innovate."

the American Hospital from a new perspective. "Influenced by my job, in which I appeal to the generosity of others to support the Hospital, I began to realize that there was no reason why I shouldn't contribute as well. And so I became a donor, too. Every year, I make a donation within my means. From experience, I know that little streams make great rivers! Donations, no matter how big or small, are the only resource available enabling the Hospital to guarantee excellence and medical expertise, to manage patients' health in such an organized manner while making them feel incredibly at home."

When asked to expand on her personal reasons for becoming a donor, she quickly responded, "I believe in the institution – in its commitments and ability to make progress and innovate. As I have witnessed for the last 40 years, the American Hospital of Paris isn't afraid to reassess itself, and never rests on its laurels."

In a few days, Agnès will be retiring from the American Hospital of Paris, and a new chapter of her story will begin. "It's a huge change that I choose to not reflect on too much for the time being," she said with a laugh. "I'm happy to have spent my entire career at the Hospital, but I'm also happy to retire! I will definitely come back, because I am a patient here."

# Donor Generosity Drives Innovation at the American Hospital of Paris

In 2024, we made an appeal for donations to bring to fruition an ambitious innovation program at the American Hospital of Paris. By autumn of that year, we began setting up our Center for Clinical Research and Innovation thanks to the generosity of our donors.


In line with our 2024-2028 strategy focused on innovation and becoming a recognized private teaching hospital, the center's purpose is to accelerate the development of clinical research and innovation programs at the American Hospital of Paris. This involves providing support to contributing doctors at every step of their project, from inception to completion. Thanks to their professional networks, our Hospital experts create opportunities for the center to collaborate with research leaders and former clinical research unit heads from France and abroad.

In November 2024, a scientific committee was formed made up of five members: Professor Benoit Gallix, Dr. Naziha Khen-Dunlop, Professor Arnold Munnich, Professor Mahasti Saghatchian and Professor Olivier Vignaux. Their mission is to evaluate each clinical research proposal submitted to the Hospital. Since the committee's first meeting on November 4, 2024, it has reviewed nine proposals, five of which earned the highest score ("A") and could therefore be launched.

### These include:

> The financing of Dr. Claire Thuillier's dissertation work entitled: Risk of maternal death in low-risk women according to the planned mode of delivery, with a view to publication in collaboration with INSERM (Institut national de la santé et de la recherche médicale), France's national health and medical research body, and Columbia University in the United States.

- > The launch of ENDOBEST, a clinical trial that studies how saliva test results can influence medical decisions in the treatment of female patients with debilitating symptoms suggesting endometriosis, but whose MRI results show no lesions.
- > Our participation in France PCI (for Percutaneous Coronary Intervention), a national register that tracks coronary angiogram and angioplasty procedures performed in France.
- The continuation of our collaboration with the company Music Care enabling our patients in surgery, dialysis and outpatient care to enjoy the benefits of music therapy. This non-medicated approach helps reduce stress, pain and anxiety in patients, thereby improving their comfort and care experience.
- > The March 2024 launch of an innovative project with the startup Kiro, designed to enhance the experience of patients undergoing lab tests and facilitate the interpretation of results. This initiative is part of our effort to deliver increasingly personalized preventive medicine. Kiro uses artificial intelligence to flag similar patient profiles, thus facilitating the early detection of disease and identifying new biomarkers. This partnership also includes an important research component, in order to jointly build useful and relevant care pathways.

- The upcoming introduction of an immersive medical imaging solution for breast cancer patients. Using a virtual reality headset, patients will be able to visualize their disease and gain a better understanding of their care pathway. We want to assess how the use of this technology impacts treatment acceptability while reducing stress and anxiety.
- The development of other AI-based projects in high-growth fields such as nuclear, vascular and reproductive medicine.
- The identification of the best diagnostic tools for our radiologists, such as BoneView (which helps emergency physicians in the event of a suspected fracture) and ChestView (for the detection of pneumothorax), in partnership with Incepto.

In 2025, our Center for Clinical Research and Innovation will continue to grow and expand its reach both in France and abroad. The American Hospital of Paris thanks all the generous donors who support these initiatives, which play a major role in securing the future of public health.

# Medical Exchange Program: Deepening Cooperation with Our North American Partners

The American Hospital of Paris commits each day to providing the excellence of French and American medical practices to its patients. With support from the Florence Gould Foundation and from the American Hospital of Paris Foundation in New York, our scientific and medical partnerships with the United States have intensified in recent years. In particular, we collaborate closely with our longtime partner NewYork-Presbyterian Hospital and its affiliate universities Columbia University and Weill Cornell Medicine, as well as Brigham and Women's Hospital and Harvard Medical School in Boston, Massachusetts.

These partnerships, which strive to reinforce cooperation in terms of clinical practice, research and teaching, have led to collaboration in 20 different medical specialties. For example, we will soon be introducing a multidisciplinary committee in partnership with Weill Cornell Medicine's breast cancer team. Patients will be able to request a second opinion from the committee's experts, if they wish.

As part of this initiative, several doctors from the American Hospital of Paris travelled to the United States in March 2025 to meet their peers. Together they addressed topics such as pediatrics (in view of the opening of our future pediatric center; see special feature on p. 4), as well as nuclear medicine and gastroenterology.

Several members of our Development Office also traveled to the United States to attend fundraisers organized by generous donors in New York, Dallas and Houston. Their presence helped strengthen ties with local patrons and further build the renown of the American Hospital of Paris on the other side of the Atlantic.

# Why Not Put Your Taxes to Work for the Pediatric Medicine of Tomorrow?

The IFI wealth tax applies to non-commercial real estate assets, including primary and secondary residences, land, real estate investment trusts and rental properties. It is calculated based on what you report in your tax returns, and concerns assets owned by French residents in France or abroad, as well as foreign residents with assets in France.

If you pay the IFI wealth tax, you are probably already aware that the only way to lower this tax is by reducing your holdings. However, the French government allows you to freely allocate part or all of your owed taxes to a charitable organization you care about.

You can decide where and how your money is used by simply making a donation.

# Freely Allocate Your IFI Wealth Tax to the American Hospital of Paris

The American Hospital of Paris enjoys special status in France as an institution of public benefit. This means that 75% of your donation can be credited against your IFI wealth tax on real estate assets, with a maximum savings of €50,000. For you, this is an easy and efficient way to become personally involved in your Hospital's development, in particular by helping finance our new pediatric center of excellence. Your help is not only precious but crucial to our institution, as we receive no public funding from the French or American government. We rely solely on the generosity of donors and private benefactors to carry out ambitious projects like this one.

## Your IFI donation explained in 4 steps

1

### Calculate your donation amount

Divide the amount owed in IFI wealth tax by 0.75. This will give you the donation amount necessary to reduce your tax to €0.

For example if you pay €3,000 in IFI tax, a donation of €4,000 will reduce your IFI tax bill to €0.

### Make your donation

To reduce your 2025 IFI tax, we must receive your donation before the tax filing deadline (between late May and early June, depending on which French département you live in).

### Report your donation amount on your tax return

Because you have already paid for your donation, your tax incentive will take immediate effect.



### Keep your tax receipt

As soon as we receive your donation, we will issue your tax receipt. Keep it in a safe place, as you might be required to provide it to the tax administration.

### Optimize your tax benefits

You cannot benefit from a tax incentive on your IFI wealth tax and your income tax simultaneously, but you may choose to split your donation amount between the two taxes. For example, if you donate €15,000, you may divide this amount between your IFI wealth tax and your income tax as follows:

**IFI** wealth tax: **€10,000** for a **€7,500** tax credit (**€**10,000 × 75 %)

Income tax: €5,000 for a €3,300 tax credit (€5,000 x 66 %)

### If you do not pay the IFI wealth tax

If you do not pay the IFI wealth tax on real estate assets, supporting the American Hospital of Paris can still be advantageous, because you can credit your donation amount against your income or corporate tax bill.

- > 66% of your donation amounts can be credited against your income tax bill (the credit must not exceed 20% of your taxable income)
- **>** 60% of your donation amounts can be credited against your corporate tax.

### If you are a United States tax resident

The American Hospital of Paris issues tax receipts that can be provided to the American tax administration so you can benefit from tax incentives in the United States.
